# FY15 UPDATES

# FY15 Updates

- ▶ Admission date and change in district relationship from 3 or 2 to 1
  - ▶ Will look at later of FS Effective Date or FS Admission Date
  - ▶ District will only be funded once student is receiving instruction
- ▶ Date of Spring Administration – Math Test Element on DL Record has been eliminated!

# Accountability Dates

## New calculations include

- ▶ Annual Measurable Objectives (AMO)
  - ▶ All students enrolled on the Participation Date are included
  - ▶ Participation Date determined by which test type is taken
- ▶ Majority of Attendance (MOA) start date
  - ▶ Remains Friday of first full week of October
  - ▶ FY15 = October 10, 2014
- ▶ Majority of Attendance (MOA) end date
  - ▶ Varies depending on exam

# MOA – Which Date?

- ▶ If a student is taking an alternate assessment, then use March 19
- ▶ For standard assessments
  - If *only* taking a fall block exam, then March 19
  - If taking both fall and spring exams, then use the relevant spring date
  - Which spring date to use
    - If the student is taking ELA or math, then use that date
    - If the student is not taking ELA or math and is only taking science and/or social studies, then use that date



# SCR Updates

- ▶ When updates are submitted, if a change to an element is detected, the record will display with a triangle icon
- ▶ Click on the triangle to view the details on the old and new values for the changed element(s)

# SOES Updates

- ▶ Community school view
- ▶ Audit information can be viewed from the Educating Entity detail screen
  - ▶ Click the blue triangle icon to the left to view audits

# SOES Updates, cont.

- ▶ When a community school changes a resident district IRN
  - ▶ Previous district will no longer see the record
  - ▶ Unflagging the student will not be necessary because the record will disappear
- ▶ Derived enrollment date
  - ▶ Latest of the FS effective date, FS admission date, or DL first day of school

# Data Collector – Level 1s

## Enrollment reports

- Detail and Summary
  - Based on data from latest prepare
  - All students currently enrolled as of the latest prepare
  - Gender has been added to the detail report and will appear for the TD Midyear S Collection
- A third enrollment report
  - All students who have withdrawn or have future enrollment dates (so all students who are inactive)

# FTE CALCULATION AND REPORTS

# FTE Calculation

- ▶ Calculation is based on
  - ▶ DL first day of school,
  - ▶ FS admission date,
  - ▶ FS effective date, and
  - ▶ FS percent of time
- ▶ Enrollment begins on the latest of these three dates
- ▶ Formula  
$$(\text{Enrolled Hours} / \text{Calendar Hours}) \times \text{Percent of Time}$$



# FTE Reports

- ▶ There will be four FTE reports
- ▶ All four will be Level 2s
  - ▶ The first two will be released toward the end of January
  - ▶ The other two will be released before the end of March

# FTE Report 1

- ▶ This report will include *all* students who generate FTE for the district's payment
- ▶ Traditional districts, JVSDs, and community schools; also ESCs, though that may come later
- ▶ This replaces the .csv FTE Flow Report; it is not exactly the same, but is similar
- ▶ Includes data for subgroup weighted funding
- ▶ No CTE course weights on this report

# FTE Report 1, cont.

- ▶ Preliminary FTE based solely on district's FS/FD records and calendar data
- ▶ Adjusted FTE based on cross district data and other adjustments to FTE
- ▶ Multiple rows for students who have changes on FS or FD records
- ▶ Source of data used for making FTE determination
- ▶ This is the report the superintendents will sign off on at the end of the year

# FTE Report 2

- ▶ Details the FTE adjustments
- ▶ Replaces the FTE Adjustment Report and the Disability Not Funded Report
- ▶ A row for each adjustment made to a student's FTE
- ▶ If data changed such that adjustment no longer applies, that row will drop off of the report
- ▶ Equals the difference between the preliminary FTE and the adjusted FTE on FTE Report 1

# FTE Report 2, Adjustments

- ▶ More than 1 FTE
  - Within one district or across districts
- ▶ Overlapping dates of enrollment
- ▶ More than 100% of time
- ▶ Disability weights
- ▶ 105 hour withdrawals

# FTE Reports 3 and 4

## ▶ Report 3

- ▶ Students reported by a district who do not generate funding for the district
  - ▶ OE out students, for example

## ▶ Report 4

- ▶ FTE summary
  - ▶ Will roll up the FTE Report 1 into summaries
  - ▶ Replaces the text version of the FTE Flow Report

# HB 367 – 105 hours

- ▶ ORC §3317.034(C)(3) was deleted
  - ▶ Applied the 105 hour rule to traditional districts
  - ▶ 105 hour rule remains in effect until March 23\*
    - ▶ Traditional districts should continue to use withdrawal code 76 until that time
- ▶ Still in effect for community/STEM schools; that law was not changed (ORC §3314.03)

# HB 367 – 5 units

ORC §3317.034(E) was added

“A student in any of grades nine through twelve shall be considered a full-time equivalent student if the student is enrolled in at least five units of instruction, as defined in section 3313.603 of the Revised Code, per school year.”



# HB 367 – 5 units, cont.

- ▶ ORC §3317.034(E) makes high school students enrolled in at least 5 units per year full time students (1 FTE)
- ▶ Still limited to 1 FTE per student
  - ▶ This is 5 units per year per student, not per district
  - ▶ When multiple districts are educating, districts will have to work together to determine percent of time

# HB 367 – 5 units, cont.

- ▶ Shifts the focus from hours the student is enrolled to units in which the student is enrolled
- ▶ Open questions
  - ▶ Will this be retroactive, as of the March 23\* effective date of the bill, or next FY?
  - ▶ How will this work with College Credit Plus?
  - ▶ What about study hall, as this is not course instruction (i.e., does not meet definition of “unit”)?

# INITIAL STAFF/COURSE (L) COLLECTION

# Staff/Course (L) Collection

- ▶ Will remain open through February 27
- ▶ Invalid certification report
  - Level 2
  - Two reports
    - Invalid cert: staff *with* errors – should shrink as issues are resolved
    - Valid cert: staff *without* errors – should grow as issues are resolved
- ▶ Report card measures based on Initial L Collection

# HQT and Invalid Cert – Teachers

## ▶ Report all co-teachers

- ▶ If multiple co-teachers for equal amount of time, co-teacher with proper cert is evaluated
- ▶ If multiple co-teachers for unequal amount of time, co-teacher with most days is evaluated

## ▶ Report all lead teachers

- ▶ The teacher reported as lead teacher for the most days is evaluated
  - ▶ Length of course
  - ▶ Number of days in session on the calendar

# Invalid Cert – Students

- ▶ Report all students in the course
- ▶ Students in the course between evaluated teacher's course start and end dates
  - Includes *any* overlap days between student and evaluated teacher, even a day or two
  - This group of students is considered when comparing
    - Student grade level to teacher credential
    - Student disability condition to course student population and teacher credential

# Invalid Cert – Students, Cont.

- ▶ For courses with end dates *prior to* the close of the Initial L Collection
  - ▶ Student grade level and disability condition reported as of end of course
- ▶ For courses with end dates *after* the close of the Initial L Collection
  - ▶ Student grade level and disability condition reported as of the close of Initial L Collection

# Traditional Midyear and CS/STEM Final S Collections

- ▶ Initial data submitted along with additional records indicated in following slides
- ▶ If new element is added to FS, FD, or FN records that results in a fatal error, the student will not be included
  - ▶ Other records with new elements added with fatal errors will just fatal out that record
- ▶ FS – will begin checking attendance

# Additional Records, cont.
