COLLEGE CREDIT PLUS (CCP)

CCP Step-by-Step Guide

OEDS Roles for CCP Module

- ▶ Roles that will give access to view data only
 - **Data View-CCP (NEW)**
- ▶ Roles that will give access to view data and view/add comments, reviews, flags
 - **Verifier-CCP (NEW)**
- ▶ By default, roles that will give access to view data and view/add comments, reviews, flags
 - **Superintendent**
 - **Coordinator-EMIS, Director-EMIS, Supervisor-EMIS**

Planned CCP Review Flags

▶ Student Course Flags

- ▶ Data Issue (similar to SOES)
- ▶ Not enrolled in this district as of CCP “Enrollment As Of” Date
- ▶ Student beyond full time for CCP
 - ▶ Total of CCP Semester Hours and HS Grad Credits x 3 is greater than 30
 - ▶ Course may not be fully funded

▶ Agreement Flag

- ▶ Negotiated Rate Per Credit Hour Agreement does not match district records

CCP CTE Information

- ▶ Current priority is getting CCP courses/agreements approved
 - Need to report all CCP courses with curriculum code of PS
- ▶ ODE realizes some CTE courses represent a significant financial cost for the district
 - EMIS is working with Career Tech office to determine criteria for CTE weighted funding of a CCP course
 - Possibility that CTE courses will be funded based on CCP delivery type
- ▶ CTE funding based on FY16 data will not start before February

SECURE DATA CENTER (SDC)

Secure Data Center

- ▶ Open week of November 16 for reviewing reports relevant to FY15 LRC
 - ▶ Traditional districts, Community schools, STEM schools
- ▶ Initial focus should be on Grad Rate, K-3 Literacy, and Prepared for Success data
- ▶ Appeal windows opening soon for Grad Rate and K-3 Literacy data

FY15 K-3 Literacy Measure, cont.

- ▶ Report initial diagnostic only
 - ▶ Students required to complete diagnostic in reading by September 30
 - ▶ Verify data is correct in End of Year S Collection
- ▶ Calculations rely on “Where Kids Count” rules
 - ▶ Student enrolled prior year for grades K, 1, and 2 and current year for grade 3
- ▶ Students identified as “not on track” are to be placed on a RIMP

Ohio's Third Grade Reading Guarantee ensures that students are successful in reading before moving on to fourth grade. Schools must provide supports for struggling readers in early grades. If a child appears to be falling behind in reading, the school will immediately start a Reading Improvement and Monitoring Plan. The program ensures that every struggling reader gets the support he or she needs to learn and achieve.

Students have multiple opportunities to meet promotion requirements including meeting a minimum promotion score on the third grade state reading tests given in the fall and spring. Students have an additional opportunity to take the state assessment in the summer, as well as a district-determined alternative assessment.

How many third graders scored proficient on the state Reading test? **88.3%**

FY15 Student Cross Reference

- ▶ Verify SCR is up to date and in sync with latest End of Year S Collection submission
- ▶ Resolve Student Cross Reference Conflicts
 - ▶ EPCT – Exceeded percent of time for student; students total percent of time exceeds 100%
 - ▶ WTIC – Withdrawn to IRN conflict; SSID is not found in submitted data from the withdrawn to IRN

- ▶ Verify the FTE on the FTE Detail Report
 - ▶ 1.00 for students enrolled entire school year
 - ▶ Less than 1.00 for students not enrolled entire school year
 - ▶ Verify admission and withdrawal dates
 - FY15 End of Year S Level 1 Enrollment Reports
 - ▶ Calculate days enrolled
 - FY15 End of Year C Level 1 Calendar Reports
- ▶ Enhanced report due out November 23
 - ▶ Verify that data on students with adjustments is correct (Start/End Dates, How Received Reason, Percent of Time)

Assessment Collections

Review Missing Student Reports to identify students with these common issues

- Was student required to be assessed, but was not?
 - Report appropriate Score Not Reported (FA235) reason
- Was student incorrectly coded as being enrolled during the testing window?
 - Make corrections in student software for FY15 school year, retransfer to data collector, collect, prepare, resubmit FY15 Final S collection
- Was SSID incorrectly reported in vendor file for a student not required to test?
 - Report New Score Not Reported reason “H”

Unexpected Results Report

New Assessment Preview Report

- Report is not run for all A Collections
- Refer to Release Notes to determine whether report is run for a particular A Collection
- Verify that students are correctly appearing on report
 - Students incorrectly reported with a test result could negatively impact LRC measures

New Score Not Reported Reasons

- ▶ **G** – EOC assessment (GE) not given for the course in which the student is enrolled within this district
- ▶ **H** – SSID for this student appears on the assessment vendor file due to a data error; student with this SSID was not required to be assessed
- ▶ **W** – EOC score not reported, student received graduation credit for assessment area due to course completion prior to end of course assessment availability; Number in score field represents number of graduation points earned
- ▶ **X** – EOC score not reported, student received graduation credit for assessment area due to completion of a dual credit course; Number in score field represents number of graduation points earned
- ▶ **Y** – Student transferred in with course already completed; number of required graduation points reduced

FY15 Where Kids Count Report

Where Kids Count (WKC) Report

- ▶ Verify that correct Majority of Attendance (MOA) IRN has been reported for students meeting Full Academic Year (FAY) criteria
 - ▶ Use FN Preview Report from FY15 Final S Collection to verify MOA
 - ▶ Use enrollment reports to verify enrollment dates for meeting FAY
 - ▶ Verify that accountability IRN has been assigned correctly
- ▶ Verify that student has been assigned to the correct WKC IRN based on the WKC code assigned

FY15 SOES

- ▶ Districts should not flag students who were enrolled at a community school in FY15 but have not yet been reported as withdrawn from that community school and are currently enrolled at the district for FY16
- ▶ December 18 – Last day for resident districts to add a flag
- ▶ January 19 – Last day for resident districts to remove a flag
- ▶ January 20 – Any remaining flags can be appealed by a community school by this date
 - ▶ Notify Area Finance Coordinator

FY16 CHANGES ON THE HORIZON

FY16 Beginning of Year S Collections

▶ Enrollment Reports Tips

- ▶ Separate by building to allow for building staff to review grade level, percent of time, how received, sent to elements
- ▶ CSV reports exported into a spreadsheet allows sorting by each of the elements
 - ▶ Look for mismatches in data, e.g., District Relationship = 1 and Percent of Time = 0

▶ Critical dates

- ▶ Casino Count – Friday of first full week of October
- ▶ Federal Child Count – October 31

New Options

- ▶ New DN attribute under Student Group Lunch area “Does Not Serve Lunch”
 - ▶ STULNCHNOT - Does not participate in the NSLP and does not know the number of students eligible for F&R lunch
- ▶ New Withdrawal Code FS100
 - ▶ 35 – Resident student withdrew from Educating Entity with a reason code that indicates the resident district no longer has a responsibility for the student

New Options, cont.

- ▶ New Admission Reason Element (FS080)
 - ▶ D – Student 22 years or older
 - ▶ Option used for IBM SSID system and not reported to EMIS
- ▶ New DN attribute to report a building participating as a Physical Education Pilot
 - ▶ PHYSEDPLOT with IRN of building participating in the pilot
- ▶ New LEP option
 - ▶ S – LEP student enrolled in U.S. schools for second year

New Options, cont.

- ▶ New Calendar Group General attribute to indicate why the calendar is exempt from the normal minimum total hours/days
 - ▶ C_CLDRSPEC with a number to indicate why this calendar is exempt
- ▶ New Assessment Area Code added for End of Course Assessment Type GE
 - ▶ Biology – BIOL

New Disadvantage Options

- ▶ Specific to Community Eligibility Participant (CEP) buildings only at Traditional Districts/JVSs
 - ▶ 4 – CEP building/LEA reporting Economic Disadvantage, student does **not** meet economic disadvantage conditions
 - ▶ 5 – CEP building/LEA reporting both Economic and Academic Disadvantage, student does **not** meet economic disadvantage conditions

New Disadvantage Options, cont.

- ▶ 6 – CEP building/LEA reporting Economic Disadvantage, student **does** meet economic disadvantage conditions
- ▶ 7 – CEP building/LEA reporting both Economic and Academic Disadvantage, student **does** meet economic disadvantage conditions

Changes

Preschool ELA assessment changes

- Added new Assessment Area Codes
 - RWA – Relationships with adults
 - VOC – Vocabulary
 - NBSN – Number Sense
- Deleted Two Assessment Area Codes
 - W – Writing
 - CLRF – Classification
- Changed Area Code Description
 - PLR – Phonological awareness (formerly Phonics and letter recognition)

Changes, cont.

- ▶ Sent Reason Element (FS200/FS230)
 - Option PS – description changed to “College Credit Plus Program Participant”
- ▶ Curriculum Code Element (CN310)
 - Option PS – description changed to “College Credit Plus”
- ▶ Disability Code (FD130) and Outcome ID (GE120)
 - Option 09 – description changed to “Intellectual Disability”

Changes, cont.

Program of Concentration, FY16

- ▶ Fewer codes used to indicate the primary CTE Workforce Development Program of Concentration
- ▶ “FY16 CTE Program of Concentration Element changes” document lists which codes remain and which have been removed
 - ▶ EMIS > Technical Documentation > EMIS Change Committee Conference Calls > November 10, 2015

Updates

- ▶ Removed Assessment Area Codes
 - ▶ AGL1 for assessment type GE, EOC exams
 - ▶ CL03 (ServSafe) for assessment type GW (Industry Credential); already included as CH75
- ▶ Update HQT_CODE (CU100) to refer to new licensing exams
 - ▶ 1 NTE/Praxis II/OAE – State Licensing Exam
