Data Collection Calendar

Effective FY17, each of the three Early Learning assessments will have its own collection request

- Kindergarten Readiness Assessment (2017AGOFL)
 - 10/15/2016 – 12/22/2016
- Early Learning Assessment (2017AGBFY)
 - 11/1/2016 – 6/30/2017
- Child Outcome Summary Assessment (2017AGMFY)
 - 11/1/2016 – 7/14/2017

Data Collection Calendar, cont.

- ▶ Beginning of Year Student (2017S1TRD) and SOES Beginning of Year Student (2017SAODE)
 - ▶ Close date of 12/22/16 is important for federal reporting deadlines and fall casino count
- ▶ Calendar Collection – Initial (2017CINIT)
 - ▶ Closed September 30
- ▶ Calendar Collection – Final (2017CFINL)
 - ▶ *10/4/2016 – 7/28/2017

FY17 EMIS Changes

- ▶ 45372 - Remove Assessment Area Error Bands from the KRA
 - ▶ LLSE - Language-Literacy – Error Band
 - ▶ MSE - Mathematics - Error Band
 - ▶ PDSE - Physical Development Error Band
 - ▶ SFSE - Social Foundations Error Band
- ▶ 45242 - Add Score Not Reported Reason for NWEA MAP/DORP Growth (GD) Assessment
- ▶ 45146 – LEP Students should take the KRA

FY17 EMIS Changes, cont.

- ▶ 33752 - New Subject Codes (CN050) for Senior Only Industry Credential Courses
 - ▶ Combination of a two character code followed by four position Assessment Area Code (FA205) of Industry Credential code associated with course
 - ▶ First two positions: 38
 - ▶ Last four positions: The Assessment Area Code (FA205) of the Industry Credential associated with the course

FY17 EMIS Changes, cont.

- ▶ 39128 – Update reporting instructions on Court-Placed Students
 - ▶ Facility defined by ORC §2151.65 or §2152.41
 - ▶ Reporting district is educating
- ▶ 39626 – Placeholder for EMIS changes needed for NCLB to ESSA transition period
 - ▶ Begin gathering data for three new subgroups in FY17
 - ▶ Military
 - ▶ Court/foster
 - ▶ Homeless

FY17 EMIS Changes, cont.

- ▶ 41429 – Remove requirement for Special Ed assignment area where no longer needed
 - ▶ Old codes can still be used for FY17
 - ▶ Will be deleted for FY18
- ▶ 41750 – College Credit Plus Students Denied Participation/Student Billed
 - ▶ Students who did not give notice by deadline date
 - ▶ Students who fail/drop a course, district seeking reimbursement

FY17 EMIS Changes, cont.

- ▶ 41898 – Determine which data elements on FD record can be reported with default values when student is District Relationship of ‘3’
- ▶ 42095 – Identify more details for Preschool Students
 - ▶ Which students funded
 - ▶ Location Served

FY17 EMIS Changes, cont.

- ▶ 42098 – Add Score Not Reported Code (FA235) option for KG Student With Incorrect/No Retention Reporting
 - ▶ Help with Missing list clean up
 - ▶ Appropriate for any use case
- ▶ 42423 – College Credit Plus New USAS Code
 - ▶ Total dollar amount cost of CCP textbooks to districts

FY17 EMIS Changes, cont.

- ▶ 43217 – FY17 Industry Credential (GW)
Date Field
 - ▶ Include actual date credential was earned
- ▶ 43637 – Add new position codes (CK060)
 - ▶ School Resource Officer
 - ▶ Reading Intervention Specialist
- ▶ 44480 – Add day of the month to
Assessment (FA) record layout
 - ▶ New element Test Day (FA212)

FY17 EMIS Changes, cont.

- ▶ 44504 – Allow Score Not Reported of ‘S’ for Kindergarten Readiness Assessment
 - Non-Scorable Assessment
- ▶ 44633 – LEA is also a community school sponsor
 - Track Sponsorship revenues and expenditures

PRESCHOOL SCENARIOS

FY17 Preschool Reporting Change

- ▶ 42372 - Clarify reporting instructions to specify that reporting "students you are educating" includes all preschool students, regardless of funding source
 - Non-Special Ed or "Typical"
- ▶ The following scenarios are taken from recently closed helpdesk tickets

50% ECE and 50% Non-Special Ed Preschool Student Paying Tuition at an ESC

- ▶ ESC reports
 - ▶ Tuition Type = '*'
 - ▶ Percent of Time = 50
 - ▶ How Received = 'E'
 - ▶ How Received IRN = Resident District
- ▶ Resident District does not report

Non-Special Ed Preschool Student Paying Tuition at ESC, Does Not Quality for ECE

- ▶ ESC reports
 - ▶ Tuition Type = 'D'
 - ▶ How Received = 'H'
 - ▶ How Receive IRN = Resident District
- ▶ Resident district does not report

Non-Special Preschool Student Paying Tuition at a District or Community School

- ▶ Educating district reports
 - ▶ Tuition Type = 'D'
 - ▶ How Received = '*' or 'M'
 - ▶ How Received IRN = '*****'
- ▶ If educating district is not the resident district, resident district does not report

Non-Special Ed Preschool Student Court Placed or Open Enrolled In and ECE

- ▶ Educating district reports
 - ▶ How Received = 'E'
 - ▶ How Received IRN = Resident District
- ▶ Resident District does not report

Non-Special Ed Preschool Student Court Placed In, Not ECE

- ▶ Educating district reports
 - ▶ How Received = 'C'
 - ▶ How Received IRN = Resident District
- ▶ Resident District does not report

Non-Special Ed Preschool Student Open Enrolled In, Not ECE

- ▶ Educating district reports
 - ▶ How Received = '9'
 - ▶ How Received IRN = Resident District
- ▶ Resident district does not report

SSID DEACTIVATION

SSID Deactivation

▶ Why?

- ▶ Two unique SSIDs exist for the **same student**

▶ When?

- ▶ As soon as issue is discovered
 - ▶ Waiting until an appeal process may greatly limit window of opportunity

▶ How?

- ▶ Sign in to IBM's SSID System
- ▶ Click on **Delete an Invalid SID Record** link under 'Maintenance'
 - ▶ Associated active valid SSID and deactivation reason required

SSID Deactivation, General

When two unique SSIDs exist for a student

- ▶ General rule is to deactivate the *new* SSID and link to the *old* SSID
 - ▶ This applies prior to the student being assigned to a graduation cohort
- ▶ The exception to this rule applies after a student has already been assigned to a graduation cohort

SSID Deactivation, Exception

- ▶ When a district's Longitudinal Grad Rate Report includes the SSID for a student who did not graduate from that district
 - ▶ Confirm with the Withdrawn To district that student enrolled and was assigned a new SSID, which was reported to EMIS
 - ▶ Deactivate *old* SSID and associate it with *new* SSID
- ▶ Deactivation process occurs at IBM website
- ▶ Cohort reassignment occurs at ODE based on IBM file of deactivated SSIDs

SCR Enhancements

- ▶ Import process will now include Summer Withdrawal (FL) record
 - ▶ Prior year corresponding record with 'EOY' end date will be closed, withdrawal reason applied
 - ▶ Actual FL records will not be viewable within module
- ▶ WTIC checks process will now include Sent to Reason 'SE'
 - ▶ Excluded from checks process prior to current release

Corrections

- ▶ CCP - Corrected a problem where the alternate pay flag was not getting properly set during the extract of data
- ▶ SOES - FY16 approved records with no changes were not being set to auto approved in FY17
