



Data quality issue: Enter comments to provide clarification to the community school. It will not impact funding to the community school & should be used to address commondata quality issues such as address mismatches.

SSID mismatch: SSID reported by the community school differs from the one on file at the district.

Graduated: Resident district believes that a student already has graduated from high school.

Guardianship challenge: Student is in a guardianship situation & the resident district reported by the community school is not the correct district where the parent resides or resided per Ohio law or in accordance with a court order.
