Grad Cohort Reports



Cohort Assignment

- State Equivalent Grade Level (FD090) as of October 1 for student reported in the prior year
- Fiscal Year that Student Began Ninth Grade(FN110) for student not reported in the prior year
- Use grad cohort reports to verify first year students before close of FY20 End of Year Student (S) collections

GRAD-002 Newly Assigned to Grad Cohort

- First year cohort assignment verification made easier
- Combines all cohort reports into one
 - -Based on Add Cohort by Grad Event Code column ADD COHORT BY GRAD EVENT CODE
- Use to verify accountability



How To Use Cohort Reports

- Verify students listed in cohort
- Determine if any students are missing from cohort
- Confirm that student should be included in district's denominator

2020_GRAD_Cohort-EOC-Asmnt_Detail

- End of Course (EOC) results only
- Highest score or points per student in each subject area
- All submitted results considered when determining highest score or points



2020_GRAD_Cohort-Non-EOC-Pts-Detail

Points earned through means other than EOC

- -AP and IB scores
- -IEP exemptions
- -Substitutes for EOC
 - College Credit Plus (CCP) course grade = option X
 - Non-public transfer credits = option 2
 - Coursework prior to test availability = option W



2020_GRAD_Cohort-EOC-Path-Req-Stat

- Highest points earned per subject area
 –EOC and substitute tests
- Out-of-state and home-school transfers
 –SNR = option Y
- Total of all points earned
- Final pathway determination



2020_GRAD_Cohort_SAT-ACT_Path_Req_stat

- Highest score per ACT/SAT subject area
- Test date corresponding to highest score
- Remediation-free determination
- Final pathway determination



2020_GRAD_Cohort_WK-IndCred_Path_Req_stat

 Total credential points earned in each career field

-12 points required in single career field

- Highest valid score per subject area per version of WorkKeys assessment
 - -13 points required on single version
- Determination for each part
- Final pathway determination



New FY19 Cohort Appeal, 1

- Open March 2-13, 2020
- Can update Fiscal Year that Student Began Ninth Grade and State Equivalent Grade Level
- Must use the 2019 Data Appeal for Cohort form available in OH|ID

-Can include FY20 Cohort or beyond



New FY19 Cohort Appeal, 2

- Appeal subject to audit
- Proper documentation
 - -Must be kept by district
 - -Made available to ODE upon request
- In the future, this appeal will be open after cohort graduates in the fall

Preschool Transition



Indicator 12 Calculation

- Measures percentage of students referred by Part C to part B prior to age 3 for students found to have disability
- Department uses IIEP Outcome Beginning Date (GE140) to determine compliance during FY20

-Previously used IIEP event date



PS Transition Conference (PSTC)

- For students transitioning from Part C to Part B preschool special education
- Between early intervention provider and child's LEA
- Federally mandated to occur prior to age 3



Reporting

- Data used to determine compliance with Federal mandate
- Legal District of Residence reports

 Initial ETR confirms disability
 - -Initial IEP must be developed for Part B services
 - –Must be implemented by third birthday
- Even if DOR does not attend PSTC



What and When to Report

- Student confirmed with disability –Report PSTC, IETR, and IIEP
- Student found ineligible or parents refuse services
 - -Report PSTC, IETR, and IIEP where relevant
 - -Enroll using How Received (FS180) = V
 - Enrollment and Withdrawal date will be the date of the last event
- What if the student moves after PSTC?
 –Nothing to report



Non-Compliance ID (GE130) Mandatory

IIEP Outcome Beginning Date not on or before third birthday is late and requires noncompliance code

- -Third birthday is on a Saturday
 - On/before Friday
- -Third birthday is on leap year date of February 29
 - On/before February 28

-Third birthday occurs when school is not in session

• On/before the break

Attending Situations

- Grandparent Rule
- Power of Attorney
- Caretaker Authorization Affidavit



Grandparent Rule

- Ohio Revised Code (ORC) §3313.64(F)(11)
 - -Under the age of twenty-two
 - -In the custody of the parent(s)
 - -Resides with the grandparent
 - -No special education required
 - -Both districts agree in writing good cause exists
- Funding goes directly to educating district
 –Not on FTE Report of parent's district

Power of Attorney

- ORC §§3109.52 and 3109.53 to 3109.61
- Executed by *parent*
- Student lives with grandparent
- Legal District of Residence is grandparent's district



Caretaker Authorization Affidavit

- ORC §§3109.65/3109.67 and 3109.66 to 3109.73
- Executed by *grandparent*
- Inability to locate or custody order prevents contact
- Student lives with grandparent
- Legal District of Residence is grandparent's district

CTE Assessments



CTE Technical Assessment (GY)

- Career Tech Accountability Assessment (A) Collection
- March (D) Follow-up Collection
 - -Only for students in ODE file
 - Proficiency achieved with additional tests since prior year summative record
 - -Course-level results for every test represented by summative record must be reported



Industry Credentials (GW)

- Can be reported in any, counted the same
 - -Career Tech Accountability Assessment (A)
 - Specifically for CTE assessment reporting
 - -Other Accountability Assessments (A) Collection
 - Prep for Success measure assessments
 - -Graduation (G) Collection
 - Attempts after graduation
 - Not available to JVSs
- New test types IPD and INP

-GW records with test dates after 6/30/2019

How to Use CTAC-001 Report for March D

- Tool to help determine potential programs of concentration (POC) based on
 - -Past course enrollments
 - Reported Career Technical Assessment (GY) results
- Decide whether to appeal previously reported Program of Concentration (FN290)
 - -Not included in report

Five-Year Forecast (P) Collections

- Five-Year Forecast Initial Optional (P) Collection
 - Opportunity to submit updates on data provided in Initial Required collection
 - -Closes March 27, 2020
- Five-Year Forecast Required Spring Update (P) Collection
 - -All entities must submit
 - -Closes May 31, 2020
- Required records for each submission
 - -Five-Year Forecast (QF) Record
 - -Assumptions uploaded as .TXT or .PDF


- New Secure Data Center (SDC) workgroup —Stemmed from Reports and Impact workgroup




