# GENERAL ISSUES DATA REPORTS

## FUNCTION AND PURPOSE

The General Issues Data reports are individual checks that are generated for a district that may contain information about assessment, staff, student, and/or financial data reported through EMIS. The reports are designed to assist districts in identifying possible data quality issues and are not meant to imply that ODE considers the information presented as errors. Once the district determines that the information that is being received by ODE that they are reporting to EMIS is correct, no further action is required by the district.

The reports may be generated for city, exempted village and local school districts, community schools, STEM schools, Joint Vocational School Districts, and Educational Service Centers based on applicable data submitted via EMIS during the various Assessment (A), March (D), Financial (H), Five Year Forecast (P), Staff/Course (L), and/or Student (S) collection windows. Numerous ODE business offices perform these checks throughout the above collection windows, and the results are provided as Level 2 reports within the Data Collector one or more times per week.

## PROCESS DESCRIPTION

Offices within ODE run the checks on the data to ensure that the data look “reasonable” throughout the various collection windows. Reports are then generated to provide feedback to the districts, for many checks, this could occur multiple times per week during each collection.

## DATA SOURCE

The tolerance checks are run using the previous evening's EMIS processing. The data used for the checks may also be calculations derived by ODE, such as calculations of student FTE or for local report card indicators or measures.

## REPORT

### Layout and Fields

The numerous General Issues Data Reports are Level 2 Reports located in the Data Collector. The report names will follow the following naming convention; *(GNIS-XXX) Gen Issues – Subject Area – Title*. For Example, *(GNIS-350) Gen Issues – Gifted – Super Cognitive Large Change* is a check of Super Cognitively Gifted students across two years, and the districts with a report have exceeded the threshold set forth by the Data Manager. Additionally, as with other Level 2 reports, it is possible to view the entire report or portions of the report by Severity Code.

**RPT DEST IRN.** The IRN of the district receiving the report.

**LEVEL 2 REC TYPE CODE.** This is the code/name of the report. Note that each check will have its own report and will be GNIS- + last three digits of the result code. For example, IS0350 will be report GNIS-350.

**RESULT CODE.** Every row on the report will be assigned a Result Code.

**RESULT DESCR (Result Code Description).** The Result Code Description is the description of the result code. Each Result Code and corresponding description is listed in table 2 below.

**ERR SEV CODE (Severity Code).** Every row on the General Issues Data Reports will be assigned a Severity Code. The codes found on this report and their descriptions are as follows.

**DATA CLCTN DATE.** The date of the data upon which the report is based.

Each report may have up to five text fields, six number fields, and three date fields to help identify the specific row of data reported that may be of issue. The additional fields may also contain fields used in the derived data/calculation being checked. Furthermore, student level checks may also include the students' last name, first name, EMIS ID and/or the building IRN from the last time the student was reported by the district during a student collection window.

Additional common fields at the right side of each report will include:

QUESTN CNTCT NAME	CHECK DESCR
Data Manager/Office name, email address and/or phone number	Description of what is being checked and how to correct/review the data in the check.

**QUESTN CNTCT NAME (Contact Information).** Will display the Data Manager name and/or ODE Office, email address, and/or phone number for questions about the check.

**CHECK DESCR (Description of the Check).** Displays pertinent information about the check, which may include references to the data used and how to correct/review the data used in the reports.

Please contact him or her directly.** When contacting the listed data managers, remember that EMIS does not and cannot possess student names. Please do not include a copy of your report with names and SSIDs in your email and do not include such information in the body of your message.

**If the check lists 'Your ITC' as the contact, and the ITC is not able to answer the question, they will escalate your question(s) to ODE via the EMIS Helpdesk.**
