
December 2023 PowerSchool Ohio State Release available 12/5/23:

- Updates to the 21-22 CRDC Report for all Ohio state fields. Ohio should use the report listed on the State/Compliance page. There was also a release on 12/12/23 that had SIS Compliance CRDC updates which remove the “Draft” from the 21-22 CRDC report page. The LEA ID & SCH ID codes must be entered in both 23-24 and 21-22 for all open schools. These can be found at <https://nces.ed.gov/ccd/districtsearch/> Selecting the district will then give a list of Schools - FYI the school code is the last five digits of the NCES School ID (first seven are the district id) – 02648 in this example:

Entry items in District Info and School Info – remember to enter the Final

Grade Store Codes in each building that gave credit for Algebra I in 21-22

- The Pre-ID Ohio State Assessment Extract is updated to recognize the override on the section for block scheduled courses.
- Update to the (FA) Student Assessment - Reading Diagnostic (RD) and Tier 1 Dyslexia (DS) Test types to allow for the score of *** when a Score Not Reported Reason is entered.
- Improvement to the Reading Diagnostic Import to mark as EMIS Excluded if the KG student has a RD or GO record for the current fiscal year.
- You can now select from the Contact Relationship field as expected after the SIS Core 23.11.0.0 upgrade.

Upcoming – New OST Import for the new file layout and new accommodations will be in the first January release. This will impact all 3-8, EOC, OELPA and Alt Assessment result imports. Update to the AP Import for the two new codes as well (Pre-Calculus and African American History).

Grad Pathways will not recognize the Phys Ed credit if only 0.25 - fixed in January.

Update for the New Enhanced Menu for the State screen breadcrumb trails.

Reminder – Exiting Student Follow-Up - FLUP-001 - students with No in the Active column will need the Exclude from FW reporting marked on their FW tab.

Industry credential points list update – grad pathway... - second Jan release

Tip of the day – If your results file for Reading Diagnostics/Dyslexia has only the DCID, add the SSID or student_number to a column for import. Or is there no date column, (example - change “Fall 2023” to 10/1/23) for import.

Known Issues:

Alt-OELPA and KRA results files – Currently working with the Office of Assessment on the file layouts for these and will either get the results in the correct file layout or will have to create new imports for the existing file layouts.
