Several CRDC updates 2/8 & 2/15 with a few more today:


The CRDC 2021-2022 report is updated as follows:

- The ATHL-2 section is fixed and extracts the total value correctly.
- The COUR-11 section is fixed and displays the total IDEA count.
- The CRCO-2 section is fixed and displays an email address without any extra space if an email address is more than 19 characters long.
- The CRDC School CSV files are updated to extract blank/null if Non-Binary is set to No.
- The DISC-1 to DISC-10 sections are updated per the CRDC specification.
 - o DISC-2, DISC-3, and DISC-4 apply to students in PreK grade levels only.
 - o DISC-11, DISC-12, and DISC-13 apply to students in K-12 grade levels.
- DSED-1 and DSED-2 have been fixed to report only a single instance for each student, even in cases where a student is enrolled in multiple schools.
- The duplicate SSPR-11 field has been moved to the Deprecated Fields section on the CRDC District page.
- The SECR-1 field is now fixed to save 0.00 successfully on the UI and is also reflected in the CRDC report output.

The 23-24 CRDC collection begins 12/11/24, please forward any issues that we can investigate from the 21-22 collection that ends 2/26/24.

KRA results are now final - if you have imported scores that were downloaded prior to 1/20/24, per KRA they will need to be removed and re-imported. If your district uses the KRA to fulfill the TGRG Reading Diagnostic requirement, you can import it at any time. If your district does not use the KRA, import your KG Reading Diagnostic (RD) results file first.

Tip of the day – ODEW is now requiring Special Education Related Services to be reported again. This was removed in 2015 and each district will have to re-instate the EMIS reporting elements for the returning codes:





Schools are finding that their district chose to continue to enter these for the past nine years and in some cases did so with no end dates. Please review your GQ by the start date to make sure there are not related services being reported in error. These can be updated in bulk via DDA if filtered carefully.

Known Issues:

Schools/School Info CRDC page is not loading using the legacy menu – work around is to switch to the New Enhanced Menu and it will load as expected.

Grad Pathways – Semester 1 classes that a student has failed are still appearing as "In Progress".

ODDEX import will duplicate Fall EOC results from your district. Some results were available 1/17/24, please check any ODDEX imports after your district submitted these results to ODEW. ALG1, MTH1 and ELA2 results can impact Grad Pathways attempts needed for the Alternative Competency.

Upcoming:

Alt-OELPA results files – We are working on an import for this file layout as the Office of Assessment responded last week that this will be the layout for FY24.

Update to the Pre-ID tab for the Alt-OELPA students. Currently it is only an option when running the report.



ODEW provided the new Industry Credential points update today and we will release it ASAP.

New Course Deliver Method for Ohio Technical Center (TC) and new Sent to Reason (TC) which can generate greater than one FTE. The change will be in May, and is to be reported for FY24. Per ODEW districts should keep a list of the courses and students to enter in May.

There will more than likely also be more DN elements added in May that will need reported for FY24 per ODEW pertaining to Literacy Instruction (Chg. 24-73).

The last open FY24 change is 24-102 and we are awaiting ODEW guidance for this change.
