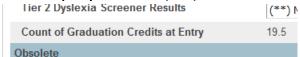
# November 2023 PowerSchool Ohio State Release available 11/22/23:

 The (FN) Student Attributes No Date Record is updated to include the new element Count of Graduation Credits at Entry. This element will be populated upon running the report using earned credit from prior year Historical Grades and display on the (FN) Student Attributes screen.



- Graduation Pathways Core Credits Section is updated to encompass all valid Science combinations.
- The (FS) Student Standing Record is updated to calculate attendance on the new Sent to Reason of EX-Expelled, when the Sent to Percentage is greater than zero.
- The New Reading Diagnostic (RD) and Tier 1 Dyslexia Screener (DS) Import is updated to invalidate records with no date and/or any score with special characters.
- The Mass Update Teacher Credential has been enhanced to include all enrollments in program codes for the current fiscal year.
- All Compliance screens are improved to add the ability to mark as Favorite in the New Enhanced Menu.

CRDC Updates – the 21-22 CRDC collection is a go. FYI – Non-binary data is optional for this collection. Last update:

#### The 2021–22 CRDC Excel Templates are now Available!

Excel Templates are tools used to record LEA- and school-level data in advance of the opening of the CRDC data submission system. The templates facilitate the process for LEAs planning to submit data in a flat file format, by arranging the data in the required format that LEAs can save as a flat file for import into the submission system. The Excel template instructions document contains descriptions of the process for entering the data into the templates and saving the data in the required flat file format.

Reminder - Local Classroom Code (LCC) Improvement — Change to the configuration to remove the zero fill to 20 characters and replace with spaces. Impacts CM, CN, CU, CV, FR and GN. Please make sure the October state release is installed prior to the close of the initial staff/course collection and any CM/CV entries will need re-entered once with the new LCC format.



Tips of the day –

If your Reading Diagnostic file contains 4<sup>th</sup> and 5<sup>th</sup> grade results, remove them prior to import to avoid invalid grade level errors.

When importing the FLUP-001 Exiting Student Follow Up for 2024, if errors occur stating Student already has a record for the 2023 fiscal year, these can be students that the FR was marked to exclude post EOY process. You can adjust the fiscal year via Data Export Manager to 2024 once confirmed.

Alt-OELPA results files - The Ohio Help Desk has stated that the template from the CRS do not currently work to upload results into Power School or other SIS systems. They are working with ODE to update/correct this and there is currently no work around to report results at this time. They advised just to be patient until a fix is available.

KRA Results Files - the KRA site stated that the reports are <u>not finalized yet</u> and they should wait until they get the email indicating they are now complete.

## **Known Issues:**

FA hand entry for the RD and DS do not accept a score of \*\*\* when the score not reported reasons are entered. We will get the fix in the next release, but in the meantime the workaround is via Data Export Manager – Edit Filtered Records.

Completed Report Status is not always displaying correctly on the zip file folder, please open to see which reports have errors.



Discussion Item – Most districts give the Reading Diagnostic numerous times throughout the school year, however only the first score is to be reported to the state, so we have built in for the Reading Diagnostic import to not import if the student already has an RD score. Due to new students throughout the year, there may be results that will need imported; however, it was brought to our attention that the schools that are using the KRA for their reading diagnostic would not want the additional reading diagnostic results entered as well. We can program for this, but wanted some input, as it would mean that for a new KG student staff would need to wait until the reading diagnostic was imported to enter the KRA scores from the prior school. In addition, schools that do not use the KRA will have to be sure and upload the Diagnostics before uploading the KRA – thoughts?
